#### 4. Report from the Section Chairman

##### *(a) Current membership of the Section Board.*

Currently the key Section Board members and their responsibilities are: Jeff Cole, Chairman; Diethard Mattanovich, Vice-Chairman; Michael Sauer, Secretary; Pau Ferrer, Treasurer; Christine Lang, Website Manager; Ursula Rinas, Sponsorship Manager; Joost Teixeira de Mattos, Section representation on the EFB Congress Organising Committee.

##### *(b) Election of the Section Board.*

All of the current members have indicated their willingness to stand for re-election. All attendees of the section meeting agreed to the re-election of the board members, there was no opposing vote.

##### *(c) Report from the EFB Executive Board.*

Until December 2009, the EFB was heavily subsidized by the Catalan government with an annual subsidy of 100.000 € per year. This supported the salaries of three staff in the Central Office in Barcelona. Considerable progress was made throughout 2010 to increase EFB income, decrease costs and yet maintain scientific activity. A current list of meetings and activities planned across the EFB has been sent to all interested individuals.

Sections make use of the EFB website to advertise their activities to the membership, but make no financial contribution towards the costs involved. In his role as EFB Vice-President, JAC is leading a Strategic Review of EFB organization and activities. EFB is currently operating at a deficit, but expects to be in surplus by 2012. A list of proposals accepted in January by the EFB Executive Board has been sent to interested individuals.

##### *(d) Contribution from the Section to ECB 2009*

None of the satellite symposia planned for ECB9 was brought to fruition. It has now been agreed that other ways need to be found to involve Sections more fully in ECB15 (Istanbul, September 2012) and other future Congresses. DM remarked that the organizers should better integrate the wishes of the sections if the sections are supposed to involve themselves.

*PF provided a short statement of the sections account since the last RPP 2008 meeting in Alghero:*

**Recent Incomes:** 5,000 € from RPP 5 (2008, Sardegna)

13,000 € from Microbial Response to Stress (2009, Semmering)

**6. Report from the organizers of the current RPP meeting**

*DM reported:*

RPP 6 had 247 registered participants, 36% students, 64% regular, 70% from academia, 30% from industry; this appears as a very good distribution. The largest group of participants was from Austria what reflects the particular interest in this topic in the Vienna region as well as a high interest from students.

The draft budget amounts to 70,000 €. 20,000 € were raised from sponsoring, including 4800 € for student grants and 1750 € for poster prices.

FEMS was again very generous and provided 6000 € in total; 12 students received grants and the travel expenses of two keynote speakers could be paid. 2 additional student grants were paid from the conference budget.

The section is grateful to Ursula Rinas for the organisation of the sponsoring.

DM underlined the importance of a functional communication with the companies in order to meet their needs to receive sponsoring.

50 participants registered in the last three weeks, this reflects a recent trend for late registration what should be taken into account when organising a meeting.

DM raised the topic of the accounting as a major challenge in context of the organisation of a meeting. The EFB central office might be of help here – however at a cost.

JAC agreed, however the handling of the financial transactions has to be resolved in a case-by-case manner at the time being.

***(a) Electron transfer in microbial metabolism and its regulation***

May 11 to 15, 2011, Backagården, Lund, Sweden, Organized by Jeff Cole and Lars Hederstedt
